01. Applicants must be registered in Sri Lanka Preferably with Telephone, Fax and E mail at the registered Office of Business. (a copy of Business Registration shall be annexed).
02. Contractor who like to register for Electrical Wiring Should have registration for EM category under CIDA registration.
03. Contractor who like to register above category 05 (5.1, 5.2, 5.3) should complete following requirement
 - 3.1 Business should be registered in Sri Lanka (Business registration should be attached with the application)
 - 3.2 Business should have CIDA registration (CIDA registration should be attached with the application)
 - 3.3 Minimum 5-year experience for the registered category
 - 3.4 Average annual contract amount must be over 15Mn for following two years (job completion reports should be attached) (2022/2023)
04. Proof of having Capacity to supplies of relevant items and also submit evidence of having satisfactorily executed orders for similar supplies works and services for major government departments' statutory bodies, Banks and Reputed Private Sector Institution last 3 years for other categories
05. Minimum 05-year experience should require for the category no 6.3, 6.4, 6.5 and 6.7. (Evidence should be attachéd)
06. The Prospective Suppliers Applying for repairing items such as machinery and equipment should have workshop facilities of their own to effect repairs, whenever necessary.
07. **Application is available at the bank web site www.rdb.lk Applicants who did not used bank prescribed format shall rejected without any notice.**
08. **Applicants who wish to register shall pay non-refundable Rs. 1,000/= per each main group(There are 09 main groups and Registration Fee for each main group isto be paid severally.)as registration fee when submitting their duly filled application.**
09. Duly filled applications for Registration of Suppliers for the year 2024 shall be send to Chief Human Resource Officer, Pradeshiya Sanwardana Bank, No: 933 Kandy Rd, Wedamulla, Kelaniya or Central, North Central, Eastern, Uva, North Western, Sabaragamuwa, Western and Southern Province Offices on or before 06th 12.2023.
10. The words **REGISTRATION OF SUPPLIERS FOR YEAR 2024** and the Group & sub group numbers should be clearly mention on the top left hand corner of the envelope.
11. Application form sets not accompanying copy of the Business Registration Certificate, evidence of having satisfactorily expected orders of similar supplies (copy of the purchase orders or contracts agreements)etc., will be rejected without notification and will not be registered.
12. A member of staff or spouse and children of employees of the Bank are applicants or Proprietors/Partners/Directors of Applicant Companies such Applicants are not eligible for Registration.
13. Names of those who fail to quote promptly for consecutive three (3) occasions when required or fail to deliver goods and services on time or who supply substandard goods, services, repairs and maintenance will be expunged from the "supplier Registration"
14. Bank reserves the right to register only the applicants whose completed applications are found to be satisfactory on evaluation of each application at the sole discretion of the Bank Authorities. If applicant not qualified the registration, bank will inform it by letter.
